





- Thursday, June 22: Area Animal Science Days District Dairy Judging Contest –Galesville, (Trempealeau County Fairgrounds). Ashley will be the lead, Julie has to be gone for work. Including travel time, the contest will be a full day event. We will provide details for the day as it gets closer.

Here is what you need to know about the 2017 dairy judging program and workouts. For those who are new to dairy judging, this will all make more sense at the May 10<sup>th</sup> workout:

- Please bring a clipboard and paper/judging materials/pencils to each and every workout. I will have extras and if you are a first year judge, we will share more on May 10<sup>th</sup>.
- We will be judging two classes at each workout. The seniors will give reasons and the juniors will answer questions (TAQ's) on at least one of the two classes each night.
- o **Juniors** include any youth who turns 10, 11, 12, 13, or 14 during 2017
- o **Seniors** include any youth who turns 15, 16, 17, 18, or 19 during 2017
- o We will be using the scantron sheets for you to record your placings. This is the same sheet that is used during the contest. So be sure and bubble in your placings completely no x's.
- o Once you have your placing complete for a class, you are to report to Kyle Moser who will highlight your placings. To show respect for your teammates and practice not talking while judging, there will be no talking to anyone except your coaches until your score is highlighted. Once you finish judging a class and have your placing highlighted, feel free to talk with your teammates, but away from where others are still judging.

We are guests at the farms that are hosting us and we are very appreciative of their willingness to open their farms to us, so please be respectful of your surroundings at each practice. Please remember when you leave the farm to say THANK YOU to the farm hosts, this is soooo important as they are being very generous in hosting the judging workout.

## Required Horse & Pony Project Safety Checks Will Be Performed That Day!

#### Note:

\*If entered in walk trot may not enter canter classes. Rule excludes the bareback class.

#### **State Expo Entry Rules:**

Must be a 4-H member in good standing and be in grades 6 -13. The horse/ pony must be carried as a 4-H project. The animal with which you qualified is the one you must use. One expo class entry MUST be a class in which the exhibitor won a blue ribbon at the county qualifying show. Qualifying classes are showmanship; equitation or driving reinsmanship; pleasure riding, or pleasure driving; trail, obstacle driving, or western riding. Bareback, halter, costume, Gymkhana or other game classes are not qualifying classes. The remaining five classes may be selected in any combination.
